ORDINANCE 23-010

AN ORDINANCE AMENDING CHAPTER 7, ARTICLE II OF THE VILLAGE
OF HAMEL REVISED CODE OF ORDINANCES REGARDING
SOLICITORS

WHEREAS, Chapter 7, Article II of the Village of Hamel Revised Code of Ordinances ("Village Code") currently specifies various regulations for solicitation activities within the Village of Hamel; and

WHEREAS, the Village now desires to amend Chapter 7, Article II of the Village Code regarding general restrictions on solicitation activities within the Village; and

WHEREAS, the Village Board of Trustees, after considerable thought and deliberation, has determined that it is in the best interest of the Village of Hamel to amend Chapter 7, Article II, of the Village Code in the below manner.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES FOR THE VILLAGE OF HAMEL, ILLINOIS, AS FOLLOWS:

SECTION 1 - INCORPORATION: The above recitals are incorporated by reference herein as express findings of fact.

SECTION 2 - AMENDMENT: Chapter 7, Article II, Section 2 (7-2-2) of the Village of Hamel Revised Code is hereby amended to read as follows:

"7-2-2 CERTIFICATE OF REGISTRATION

Every person desiring to engage in solicitation as herein defined from persons in residences within the Village of Hamel, is hereby required to make a written application for a Certificate of Registration as hereinafter provided. Engaging in solicitation with the Village Hamel without a Certificate of Registration is prohibited and shall constitute a violation of the Hamel Revised Code of Ordinances, punishable in accordance with the Village of Hamel's general penalty provision."

SECTION 3 - AMENDMENT: The first paragraph of Chapter 7, Article II, Section 4 (7-2-4), following subsection (N) of the Village of Hamel Revised Code is hereby amended, in part, to read as follows, with all other remaining portions of Chapter 7, Article II, Section 4 remaining unchanged:

ORDINANCE 21-010

“All statements made by the applicant upon the application or in connection therewith shall be under oath. The Village shall require every applicant or individual who will be engaged in solicitation activities on behalf of the applicant with the Village to submit to fingerprinting in connection with the application for a Certificate of Registration by having the applicant and all individuals engaged in solicitation activity to submit to a fingerprint background check through the Illinois State Police. The Village will provide applicant the Fingerprint Vendor contact information and requirements for submission of the fingerprints to the Illinois State Police. Only after all fees have been paid and the fingerprint background check reports have been reviewed and approved by the Village will the Village issue the Certificate of Registration with the dates approved for solicitation.”

SECTION 4 - AMENDMENT: Chapter 7, Article II, Section 9, of the Village of Hamel Revised Code is hereby Amended to read as follows:

“**7-2-9 FEES.** Upon making an application for a Certificate, the applicant shall pay a non-refundable application fee in the amount of **Fifty Dollars (\$50.00)**, per person, per day engaged in the solicitation activities.”

SECTION 5 - AMENDMENT: Chapter 7, Article II is hereby amended through the creation of new Section 10 to read as follows:

“**7-2-10 PENALTY.** Any violation of any provision of Chapter 7, Article II is deemed a violation of the Hamel Revised Code of Ordinances, subject to prosecution as an Ordinance Violation, and punishable in accordance with the Village of Hamel’s general penalty provision.”

SECTION 6 - EFFECTIVE DATE: This Ordinance shall be effective as of the date of its adoption, execution and publication as provided for by law, with the penalty provisions contained herein taking effect 30 days from the adoption, execution and publication as provided by law.

Fingerprint Based Background Checks
